1. Introduction

The Environmental Impact Assessment (EIA) Report (Register No.: AEIAR-196/2016) prepared for the "Tung Chung New Town Extension" (hereinafter referred to as "the Project") has been approved by the Director of Environmental Protection, and an Environmental Permit (EP) (Permit No.: EP-519/2016) has been issued for the project under the Environmental Impact Assessment Ordinance.

The submission of Management Organizations has been prepared in accordance with Condition 2.11 of the EP, which includes the following information:

- (a) the management organization of the main construction companies and/or any form of joint ventures associated with the construction of the Project;
- (b) the management organization of the Environmental Team (ET); and
- (c) the management organization of the independent Environmental Checker (IEC) and the supporting team.






